Disaster Relief Financial Assistance Request

The National Fraternal Order of Police Disaster Relief Foundation has established a fund to assist law enforcement officers who have suffered a severe loss caused by a disaster. Only damage to the home itself and contents will be considered. This assessment form will be used to determine the needs with approved applicants receiving a cash grant to assist in their time of need.

To be eligible, you must be an active member of a local lodge of the Fraternal Order of Police who has sustained severe damage or loss of use of your property. Assessment applications must be received by and coordinated with your State Lodge. The Disaster Relief Committee will review your application and assistance will be provided based on need, damage suffered and availability of funds. This grant is one per family and is not intended to be a supplement to insurance but rather immediate emergency assistance for those **displaced** from their homes.

Applications must be submitted no more than 45 days following the disaster.
